Ethics in Politics By William Brian Wardman

Many companies around the world have their employees take classes in ethics. This is to ensure that all employees and their families understand ethics laws. For example, if your position is privy to inside information regarding development, you, or any family member, cannot profit from that information. Another example would be that you cannot accept gifts, of any size, because of your position. Depending on the industry, there are internal and external agencies that track and monitor infractions that may occur. Not following ethics can result in loss of credibility, loss of business, loss of job, financial fines (both personal and company), and jail time.

Unfortunately, many elected government officials who represent voters have shown a disregard for ethics. How often have we heard the following?

- The purchase of property at a development site not yet known to the public.
- Taking money from developers and architects for zoning changes. (See Chicago Tribune, Sunday December 9, 2018, Beyond designing, architects donate).
- Taking money from an industry which legislators regulate.
- Receiving free or discounted Chicago Cubs Tickets or free parking.
- Obtain multiple anonymous social media accounts for the purpose of attacking citizens.
- The list goes on and on.

I must clarify, if someone is violating ethics, that does not mean it is illegal. There is a Chicago Board of Ethics set up to help improve public perception and confidence of the City officials and workers. The purpose of the Ethics board is stated within the Introduction as follows:

" The Chicago Board of Ethics (the "Board") was created to administer the City's Governmental Ethics Ordinance (the "Governmental Ethics Ordinance" or "Ordinance"), which is Chapter 2-156 of the Municipal Code of the City of Chicago ("the Code"). The Board is charged with maintaining records, educating City employees, officials, lobbyists and the public regarding ethical standards in Chicago government, issuing confidential advisory opinions, and adjudicating and/or settling charges resulting from investigations regarding matters related to the Ordinance."

There is an ethics pledge which employees and officials can accept whether they will follow ethics laid out by the City. It is not required for officials to take this pledge. It should be noted that most of the Aldermen did not take the pledge.

The City of Chicago Board of Ethics Ordinance as stated above (<https://www.cityofchicago.org/content/dam/city/depts/ethics/general/Ordinances/Rules-Reg-2014.pdf>) outlines ethics and provides penalties if they are violated by public officials. If we have such an Ethics Ordinance, why are some of these violations not being addressed properly and appear to be without consequences? The people that are managing ethics review and penalties have very little authority; and every-day citizens do not even know that this "Ordinance" exists and that they are able to file complaints. The impact of elected officials not following a code of ethics is the continued break down of public confidence in our elected system. This can be shown in poor election turnouts.

What can be done? As citizens, issue complaints with evidence to the Ethics Board on violations. All ages should become more involved in being part of ethics boards and being part of the solution. Moving forward, there needs to be a change in the paradigm. This is what happened with the Chicago White Sox scandal in 1918. An autonomous commission (this could be the Board of Ethics) that is non-partisan needs to be empowered and should be separate from elected officials. They should have the ability to initiate penalties to violators and provide evidence to federal law enforcement if there are any illegal activities.




