The number of residential units on any block in Illinois could double or more, plus half of those could be affordable housing units, and our local elected officials cannot do anything about it if HB 3552 and HB 1813 became law.

An Accessory Dwelling Unit (ADU) is the restructuring of an existing space (such as attics, basements, coach houses, or garage) transforming into an additional residency along with the already existing legal residence.

Two bills have been introduced in Illinois, HB 3552 and HB 1813.

HB 3552 says a local government cannot prohibit the building or usage of ADUs, no parking needs to be provided for an ADU if an application gets no response in 60 days, the application is deemed as approved and if an ADU application for an ADU construction gets rejected then the local government is required to provide in writing to the applicant what is deficient or defective and what needs to get done so the application can be approved. HB 1813 says that a municipality cannot prohibit the building or usage of ADUs.

Zoning determines what type of building can be put on a piece of land. If a property is up zoned it means that more people or units can be put in the same space. An example of up zoning would be if a piece of land is zoned for single family homes and the zoning is changed to allow a 10 unit building. Down zoning is the exact opposite of up zoning. In the city of Chicago zoning changes have to get approved by the alderman.

The Chicago Zoning Ordinance states some of the purposes of zoning are: promoting the public health, safety and general welfare, preserving the overall quality of life for residents and visitors and PROTECTING THE CHARACTER OF ESTABLISHED RESIDENTIAL NEIGHBORHOODS.

Zoning issues are and should remain local issues decided by local governments. If these two bills were to become law, then we could have outsiders not local to Jefferson Park dictating zoning and quality of life issues for Jefferson Park residents. This is completely unacceptable. If these two bills had become law then the local zoning laws would be bypassed when it comes to ADUs.

If these bills were to become law, they would have create more up zoning without zoning changes and without input from our local government elected officials. What problems can up zoning bring? There could be increased amounts of traffic and parking problems on main streets and side streets. More residents mean our schools will become even more overcrowded, and 911 response times could be affected. There could also be concerns about possible crime increases, lowered property values, higher property taxes, less sunlight and obstructed views. Another big issue is if existing infrastructure can possibly handle additional units and residents. This could lead to more flooding, not only on the sidewalks and streets, but also in our basements (maybe even increased homeowners insurance rates?). Developers could definitely build more ADUs and make money from them while the local residents could be affected by the problems up zoning could bring.

The city of Chicago currently has an ADU pilot program going on now. It is detailed on the city website. There are certain zones with specific rules. The boundary of the northwest zone does not go any further north or further west of the Old Irving Park neighborhood. In Chicago, properties with 2 or more ADUs every other unit must be an AFFORDABLE HOUSING UNIT for the first 30 years after it is built. It is possible the city will make this pilot program permanent and in all Chicago neighborhoods will be included.

At the time of this writing it is the second half of May 2025. The legislative session ends at the end of May 2025. These two bills have not made it out of committee and the chances of them passing before the end of May is very low, but they can be taken up during the next legislative session. I find it very alarming that these two bills were introduced in the first place and it would not surprise me if they became law. We have to watch very carefully to see if they or anything like them become introduced again. If you become aware of bills like these being introduced please contact me and the JPNA immediately. 







